

Harbour City Gift Card Terms and Conditions

(for the Private Label Gift Card with number starts with 62 925100)

By accepting, purchasing or using the Harbour City Gift Card (“HC Gift Card”), issued by 33 Financial Services Limited (“33 Finance”), you agree to be bound by these Terms and Conditions below. “You”, “your” and “cardholder” refer to the person who has purchased and / or used the HC Gift Card. “We”, “us” and “our” refer to 33 Finance.

The HC Gift Card

1. HC Gift Card is an anonymous and non-reloadable Gift Card with a pre-determined value of not exceeding HKD8,000. Each person may only purchase HC Gift Cards with a maximum total value of HK\$25,000 per calendar year. Only electronic payment (including Visa, Mastercard, UnionPay credit card, AlipayHK, FPS, PayMe and WeChatPay HK, excluding EPS, Octopus, and AMEX) will be accepted for the purchase of the HC Gift Card. For bulk orders(exceeding the total value of HK\$25,000 or above), additional verification at 33 Finance’s office (Address: Suite 710, 7th Floor, Ocean Centre, 5 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong, Monday to Friday 9:00am to 6:00pm, except public holidays) is required.
2. The HC Gift Card can only be used for payment for goods and services at outlets of Harbour City (“merchants”) accepting UnionPay Card, subject to the merchants’ final decision and judgement. HC Gift Card does not support making guarantee of payment at merchants. HC Gift Card is Harbour City’s Private Label Gift Card, its transaction is not the same as the standard UnionPay transaction. For any enquires on HC Gift Card transaction, please call Harbour City Gift Card Customer Service Hotline.
3. Each time you use HC Gift Card for any payment, the amount of each purchase with applicable fees and charges will be immediately deducted from the card.
4. The fees and charges listed in the Harbour City Gift Card Fees and Charges Table published on our website www.33finance.com are applicable to the HC Gift Card. You agree that we can directly debit the applicable fees and charges from your HC Gift Card. The most updated applicable fees and charges as stated in the Harbour Gift Card Fees and Charges Table on our website www.33finance.com should be binding on the HC Gift Card cardholder if the cardholder continues to use or retain the HC Gift Card. Any such fees and charges may be varied subject to 33 Finance’s notice for a period of not less than 30 days.

Making payment with the HC Gift Card

5. A Personal Identification Number (“PIN”) is imprinted and covered by silver scratch panel at the back of the HC Gift Card. Cardholder must use this PIN to enter the 33 Finance Prepaid Card platform by calling Harbour City Gift Card Customer Service Hotline, login our mobile app (33 eWallet), or website at www.33finance.com to change the PIN immediately. It is highly recommended to change the PIN from time to time for your card security.
6. At the time of payment, you must present the HC Gift Card and enter your 6 - digit PIN.
7. Once the available balance in the HC Gift Card has dropped to zero, the Card is no longer valid. We suggest the cardholder cut the card into halves before disposal.

Available Balance Enquiry

8. No card statement will be issued, but cardholder can apply for detailed transaction record. Detailed Transaction Record Fee applies which will be charged on each month's transaction record.
9. You can check your HC Gift Card's available balance by calling the Harbour City Gift Card Customer Service Hotline or login into our mobile app (33 eWallet), no charges will be applied.
10. You can check your transaction history free-of-charge by calling Harbour City Gift Card Customer Service Hotline or login into our mobile app (33 eWallet). You should notify us of any error, omission and / or any transaction not authorized by you within 45 days of the transaction date. If you do not notify us within the specified period, the transactions shown will be considered as correct. We highly recommend cardholders to check their own transaction records frequently.

Loss and Theft of HC Gift Card

11. HC Gift Card will not be replaced or have the remaining balance refunded if it is lost or stolen.

PIN and Card Replacement

12. The PIN will not be re-issued if it is forgotten. The cardholder needs to apply for a replacement card. Card Replacement Handling Fee applies.
13. Replacement of HC Gift Card will be issued free-of-charge in case of card malfunction which is not caused by you and the defective card is returned to us on or before the card expiry date for cancellation.
14. If the HC Gift Card is damaged due to misuse, a replacement card may be issued upon request provided that the HC Gift Card is returned to us on or before the card expiry date for cancellation. Card Replacement Handling Fee will be deducted from the HC Gift Card.
15. You will be asked to present your proof of identification for the issuance of a replacement card.
16. The replacement card, if issued, will be in the amount of the available balance of the replaced HC Gift Card in accordance with our record deducts all fees and charges.
17. We reserve the rights to decline the issuance of a replacement card.

Expiry

18. HC Gift Card is valid for 12 months from the date the card is purchased. The expiry date is embossed on the card face as VALID THRU"MONTH / YEAR". Once the HC Gift Card is expired, an Expired Card Management Fee will be charged monthly. The Expired Card Management Fee will be deducted from the remaining balance of the HC Gift Card each month until the card becomes zero balance. Cardholder may apply for balance redemption after the expiration date of the HC Gift Card as stated in Clause 22.
19. We will not accept merchant refund to expired HC Gift Card, please ensure the refund is done before the Gift Card is expired.

Exclusion of Liability

20. We will not be responsible or liable for any refusal by any merchants in accepting the HC Gift Card for the payment of any goods or services purchased. Any dispute relating to any transactions shall be settled directly between you and the merchant. In case of dispute, Harbour City Estates Limited ("HCEL") reserves

the right of final decision on all matters, at any time without prior notice. We and HCEL will not be liable to you in respect of any losses or damages that you or any third party may suffer in connection with or arising from the HC Gift Card.

Termination / Redemption

21. We reserve the rights at any time to terminate the use of the HC Gift Card and / or any services offered or to reject any transaction without giving any prior notice or reason. We shall not be liable for any losses or damages of whatever nature which you may suffer whether directly or indirectly as a result of such termination or disapproval. Upon termination, the HC Gift Card is to be surrendered to us on demand.
22. You are encouraged to spend the remaining balance in your HC Gift Card before the card expiration date. However, you may terminate the Card services and apply balance redemption at any time before and after the expiration date of the HC Gift Card. You need to visit our office in person, complete a Card Cancellation Form with identification proof and return your HC Gift Card. Please note that a Card Redemption Fee will be deducted from the remaining balance prior to cheque issuance. For HC Gift Card with balance equal to or below the applicable redemption fee, no redemption will be processed. A cheque for the remaining balance will be sent to you within one month after the claim.

Personal Data

23. You agree that we can use your personal information in accordance with our policies and practices use and disclosure of personal data as set out in our current Privacy Policy Statement (the “Statement”) and you have read the Statement from our website www.33finance.com.

Amendments

24. We reserve the rights to amend these Terms and Conditions at any time with not less than 30 days’ notice. Our website will display the current Terms and Conditions.
25. Retention or use of the HC Gift Card after such amendments become effective shall constitute your acceptance of such amendments. All matters and disputes will be subject to our final decision.

Law and Jurisdiction

26. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region (“Hong Kong”) and the parties agree to submit to the exclusive jurisdiction of the courts of Hong Kong.

General

27. If any of these Terms and Conditions is or becomes illegal, invalid or unenforceable in any respect, the remaining Terms and Conditions shall not be affected thereby.
28. These Terms and Conditions are written in both English and Chinese. If there is any inconsistency or conflict between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
